Aman Union Academy Certificates in Trade Credit Insurance

Key Features

The Aman Union Certificates in Trade Credit Insurance are designed for **graduates and junior staff** as well as **middle management and senior staff** aspiring to a **successful career** in finance, risk management and insurance. You will learn from leading finance and credit insurance practitioners as well as renowned academics how to **put insurance skills, business strategies and academic thinking into professional practice**.

The Aman Union Certificates are **flexible in the delivery**. You will study a variety of **online/distance modules** guiding you through core financial and insurance skills. In addition, participants will be prepared for management and entrepreneurial leadership in the global trade, export finance and credit industry. The programmes enable you to **work with ambitious professionals** discovering a truly transformational experience.

Programme Highlights

The Aman Union **Certificate in Trade Credit Insurance** is based on four units leading to 15 (ECTS) credits. In Semester One, you will focus on **ECA Foundations and Principles** as well as **Insurance Markets and Regulations**. In Semester Two, participants will complete **Underwriting and Portfolio Management**, and **Claims and Recovery**. The units will be delivered both by renowned Offenburg University Professors and well-reputed practitioners.

The Aman Union **Advanced Certificate in Trade Credit Insurance** is based on five units leading to 15 (ECTS) credits focusing on management and leadership. It includes **Strategic Management** as well as **Innovation and Design Thinking** for trade credit insurers in Semester One. In Semester Two, you will study three units: **Risk Management and Compliance, Digitalisation: Fintech and Insuretech**, as well as **Structuring Transactions**.



Application

An **undergraduate degree** (Bachelor, Diploma or equivalent) and sufficient **English language skills/qualification** (e.g., first degree educated through medium of English, IELTS Grade 6.5, or Offenburg language test) are required. You **submit your application to the Aman Union** for pre-screening by the Secretariat followed by final review and admission by Offenburg University.

Assessment

The programme will be assessed through **written examinations** at the **end of each semester**. Examinations may include short case studies, calculations, or multiple choice questions. Additionally, participants will be **assessed through coursework** which may include essays or individual/group presentation.

Online/Distance Learning

Learn online/distance from leading academics and practitioners, and **network with like-minded fellow professionals** from Exim-Banks, Export Credit Agencies, Multilateral Development Banks, Development Finance Institutions and commercial banks. **Take control** of where and when you learn, and **immediately apply new skills and knowledge** to your work.

PG Cert and MBA Top-Up

Participants who successfully complete an Aman Union Certificate can **transfer ECTS credits to the Offenburg University Postgraduate Certificate** (equivalent to a UK PG Diploma) in Export Finance and Trade Credit Insurance, **or to our** world-class **MBA** in Finance, Risk and Insurance (entry requirements will apply). Other universities may also accept earned credits for further studies.
