In the **Winter Semester** (starts in October), participants will complete Underwriting and Portfolio Management, and Claims and Recovery. You will also study Risk Management and Compliance, Digitalisation: Fintech and Insuretech, as well as Structuring Transactions. #### Application

An undergraduate degree (Bachelor, Diploma or equivalent with 210 ECTS) in a business-related topic and sufficient English language skills/ qualification (e.g., first degree educated through medium of English, IELTS Grade 6.5, or Offenburg language test) are required. You submit your application to KNect365 Learning for pre-screening followed by final review and admission by Offenburg University.

#### Assessment

The programme will be assessed through written examinations at the end of each semester. Examinations may include short case studies, calculations, or multiple choice questions. Additionally, participants will be assessed through coursework which may include essays or individual/group presentations.

#### **Further Studies**

Participants who successfully complete the Postgraduate Certificate in Finance, Risk and Insurance might be able to transfer ECTS credits to other Offenburg University Master programmes (entry requirements will apply). Other universities may also accept earned credits for further studies.
